

All surfaces shall be sanded smooth, with the grain, and never across it. Must be clean, dry, and finish sanded. Substrate should be free of grease, oil, dirt, fingerprints, and any contamination to ensure optimum adhesion and coating performance prop- erties. Moisture content of wood should be 6 to 8%. Surface blemishes shall be corrected and the room cleaned of dust before proceeding with finishing coats. Finishes shall be lightly sanded between coats.

WOOD FINISHING SYSTEM:

Primer - Apply SHER-WOOD® 275 White Lacquer Undercoater (P61WV6) at 3-4 mils wet. Air dry for 30 minutes with good air movement. For better filling, an additional coat of P61WV6 may be applied at 3-4 mils wet, dry and sand between primer coats.

Maximum dry film thickness for the primer and topcoat system should not exceed 4.0 mils.

Sand - Sand with 320-400 grit sandpaper and thoroughly remove sanding dust.

Topcoat – Apply SHER-WOOD® 275 White Lacquer Topcoat at 3-5 mils wet. Dry for 30 minutes with good air movement. Apply additional coat of white lacquer topcoat at 3-5 mils wet for build and appearance.

Maximum dry film thickness of the system should not exceed 4.0 mils.

Dry - allow overnight drying before packing and 24 hours before rubbing.
